

Curry Rivel Cemetery, Curry Rivel, Langport, Somerset, TA10 0HF

Fees as at 1st April 2023

The following Fees, Payments and Sums were fixed and settled under the Local Authorities Cemeteries Order 1977 (No 204) at the Curry Rivel Parish Council meeting on 1st March 2023.

Space is available for new burial plots for **cremated remains only**. Fees below for full burials relate to plots for which existing Rights have already been granted.

A Grant of Exclusive Right of Burial of cremated remains may be purchased in advance, by residents or parishioners* of Curry Rivel for single or double ashes interments. Burial Rights are granted for a period of not more than 100 years, on payment of the appropriate fees to Curry Rivel Parish Council, who retain all rights to the cemetery land.

The Parish Council does not undertake excavation of burial plots and all work must be done by an insured third party trained in cemetery work, normally local funeral directors.

Memorials may be placed on graves, where burial rights have been purchased, but not before permission has been received from Curry Rivel Parish Council and the appropriate fee paid.

Where Exclusive Rights have already been granted then no further interment, memorial (or change to the existing memorial) may take place unless written permission has been obtained from the owner of the Rights. If the owner of the Rights is deceased the parish council will need to make a Transfer of Rights, for which an administration fee is charged.

The fees, payments and sums for interments are lower for residents or parishioners* of Curry Rivel. (*Those who live in Curry Rivel now, or who have moved out of the area to a nursing home, hospital or to live with a relative for a period not exceeding 10 years).

Example 1 – Local resident Burial in existing grave for which a Transfer of Rights is necessary and additional inscription.

- Transfer of Exclusive Right to new owner £50
 - Full burial interment £330
 - Additional inscription £40

Example 2 – Local resident Purchase of Exclusive Right to single burial plot for ashes, interment and memorial.

- Exclusive Right to single plot £175
 - Interment £215
 - New memorial headstone £145
- Total £535
